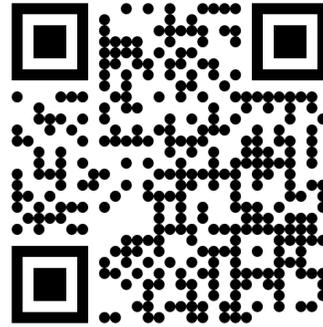

FAQs

How do I sell through the ONDC Network?

It is a simple 4-step process.

STEP 1

Register yourself and onboard onto a seller application that is ONDC Protocol Compliant.

STEP 2

Provide your KYC documents to complete registration.

Documents required are:

1. PAN Card
2. Aadhar Card (For Delhi only)
3. GST Certificate
4. Cancelled cheque for account details
5. FSSAI (Mandatory for F&B packaged items)

STEP 3

After registration, the seller network participant will create a digital catalogue of all your products. You will also get access to a seller application, where you can easily manage and track online orders, payments and update your inventory.

Where will I see my orders ?

You will receive order notifications on the dashboard of your seller application. You can choose to accept or reject the order based on stock availability and other considerations. You can also monitor live orders and track the delivery status of your orders.

Who will train me to use the seller application?

The seller network participant team will train and support you in learning how to manage and grow your business online.

How will I get my money?

Payment will typically be made within 3-7 days after the order is completed to your bank account, as per your commercial terms with the seller network participant.
